

C-Town Business

C-Town Business builds a connection between high school, college, and your future career in business. Starting in 10th grade, you will be dual enrolled at Bunker Hill Community College (BHCC) and Charlestown High School. You will earn free college credits that you can apply toward an associate's degree at BHCC or transfer to many other institutions.

You will:

- Learn critical skills in business, entrepreneurship, marketing, and/or accounting that can lead to your future high-paying career
- Earn up to **18 college credits for free**, starting in 10th grade

- Take hands-on, project-based courses
- Explore careers through work-based experiences like internships and job shadows at major Boston companies
- Connect with professional mentors one on one and in small groups

Early college is effective.

High school students who participate in early college programs are more likely to have higher GPAs, graduate from high school, and complete college degrees.

You can save time and money!

You can potentially save thousands of dollars in tuition and fees and reduce the time it takes to earn a college degree.

Get access to individualized support.

You will receive specialized academic and career advising to help you successfully transition to college and work experiences.

Get access to college resources.

When you are dual enrolled at BHCC, you will receive a real college ID and have access to all BHCC resources, including: student discounts, tutoring support, advising, college-sponsored events, and campus facilities like the gym and health center.

What jobs will these courses prepare me for?

Business courses at BHCC provide an essential foundation of key business skills, competencies, and knowledge of different types of careers and areas of expertise.

Most jobs in business require at least a bachelor's degree and some require additional special certifications.

Starting on a path to gain valuable business skills and awareness of future career options can give you a leg up when applying to business bachelor's degree programs and workbased learning opportunities that may allow you to work while continuing your education to help you advance in your career.


Each of the concentrations at BHCC can lead to a variety of future educational and career opportunities in the business field. You can find just a few examples of jobs that relate to each business concentration on the following pages.

What can I do with these credits?

After you graduate from high school, you can fully enroll at BHCC and apply your credits toward an associate's degree. Associate's degrees typically require 60 to 65 total credits—about 22 general education credits and 40 pathway concentration credits.

You can also transfer your credits to many public four-year institutions in Massachusetts.

Accounting CONCENTRATION



What is accounting?

Accounting is the way a company keeps track of how much money it earns and spends on a day-to-day basis. Good accounting is essential to the success of any company because it provides critical information that leaders can use to make key business decisions. Many individuals who study accounting take a series of exams to earn a Certified Public Accountant license.

What do Accountants do?

- Gather and organize
 information about a company's
 finances, including its expenses,
 earnings, and potential risks
- Analyze financial information to help leaders understand what it means and how to use it to make good decisions
- **Support** individuals and companies with filing their taxes

What is the Business Transfer concentration?

In BHCC's Business Transfer concentration, you will learn the foundations of business and in-demand skills, while also having the flexibility to explore a range of electives that count toward credit requirements.

This concentration will help you prepare for further education that can lead you to many different possible careers in business. The Market Research Analyst role below is just one example.

What do Market Research Analysts do?

- Collect and analyze data on customers and competitors
- Examine the potential sales of a product or service by studying markets (the groups of people who may become customers)
- Help companies determine what products people want, who will buy them, and at what price

What is entrepreneurship?

Entrepreneurship is the process of planning, launching, managing, and marketing a new business.

In BHCC's Entrepreneurship concentration, you will learn business skills that, combined with your specialized skills, can help you create opportunities for self-employment or to advance in your future career.

What do entrepreneurs do?

- **Take on financial risk** with the hope of earning more money as their companies grow in the future
- **Develop new products** and services that can help solve challenges for individuals or for society
- **Pitch** their ideas to investors
- **Market** their products and services to customers

Finance CONCENTRATION



What is finance?

Finance is the management of an individual's or an organization's money. In business, it deals with how a company earns money, as well as how it spends or invests its money. It helps the organization to run its business effectively and plan for future growth.

What do Financial Managers do?

- **Create** financial **reports**
- Help companies make decisions about good investments
- **Develop plans** and make suggestions to help an organization reach its long-term **financial goals**
- Work in many different industries, including banks, investment firms, and insurance companies


